### BE SURE TO READ AND SIGN THE RELEASE STATEMENT BELOW

I acknowledge that by signing this waiver and release, I am releasing Bicycle John's, the Palmdale Sheriff's Department, John Fries, Mike Grace and all other sponsors, and their respective agents, employees, members, promoters and affiliates (collectively "releasees") from liability. This release is a contract with legal consequences. I have been advised to read it carefully before signing. I acknowledge that cycling is an inherently dangerous sport and fully realize the dangers of training for and participating in a cycling event and fully assume the risks associated with such events and participation including, by way of example, and not limitation, the following: collision with pedestrians, vehicles, other riders or racers, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, weather conditions, and the releasees' own negligence; and the possibility of serious physical and/or mental trauma or injury associated with athletic cycling events. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I hereby waive, release, discharge, hold harmless, and promise to indemnify and not to sue the Releasees including the sponsors of this event, from any and all rights and claims including claims arising from the releasees' own negligence, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with this event, or travel to or return from this event. I agree it is my sole responsibility to be familiar with the event agenda, the Releasee's principles and rules, and any special regulations for this event. I understand and agree that situations may arise during the event which may be beyond the immediate control of the event officials or organizers, and I must continually ride so as to neither endanger myself nor others. I accept responsibility for the condition and adequacy of my equipment. I will ride wearing a helmet which satisfies the requirements of the event's Ride Rules or Regulations and that can protect against serious head injury, and assume all responsibility and liability for the selection of such a helmet. I have no physical or medical condition that, to my knowledge, would endanger myself or others if I participate in rides and events, or would interfere with my ability to participate in rides and events. I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any subsequent waiver or modification. Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the enforceability of other terms or provisions.
